This symposium will address common controversies that pediatric surgeons face day to day in the treatment of pediatric colorectal problems. The format of the course will be case presentations followed by panel and participant discussion.

- Discuss post-operative management of ARM.
- Discuss the diagnosis and treatment of Hirschsprung's disease.
- Identify various treatments in a bowel management program.
